The RSUs vest quarterly over 11 quarters. 5% of the shares underlying the RSUs will vest in each of the first three (3) quarters, and 10.625% of the shares underlying the RSUs will vest in each of the remaining eight (8) quarters, subject to continuous service through each such vesting date.
