STATEMENT PURSUANT TO GENERAL INSTRUCTION E TO FORM S-8

In this registration statement, UiPath, Inc. is sometimes referred to as "Registrant," "we," "us" or "our."

The Registrant is filing this Registration Statement for the purpose of registering:

- an additional 27,675,588 shares of Class A common stock, par value \$0.00001 per share ("Class A Common Stock"), to be issued pursuant to the UiPath, Inc. 2021 Equity Incentive Plan (the "Incentive Plan") (resulting from an automatic annual increase as of February 1, 2025 pursuant to the "evergreen" provision of the Incentive Plan); and
- an additional 5,535,117 shares of Class A Common Stock to be issued pursuant to the UiPath, Inc. 2021 Employee Stock Purchase Plan (the "ESPP") (resulting from an automatic annual increase as of February 1, 2025 pursuant to the "evergreen" provision of the ESPP).

The shares being registered pursuant to this registration statement on Form S-8 are the same class as other securities for which the following registration statements (the "Prior Registration Statements") relating to the Incentive Plan and the ESPP were filed with the U.S. Securities and Exchange Commission (the "SEC"): Commission File No. 333-255420, filed by the Registrant on April 21, 2021; Commission File No. 333-264123, filed by the Registrant on April 5, 2022; Commission File No. 333-270846, filed by the Registrant on March 27, 2023; and Commission File No. 333-278289 filed by the Registration on March 28, 2024.

In accordance with General Instruction E of Form S-8, the contents of the Prior Registration Statements are incorporated herein by reference and made part of this Registration Statement, except as amended hereby.

For the purposes of this registration statement, any statement contained in a document incorporated or deemed to be incorporated by reference herein shall be deemed to be modified or superseded to the extent that a statement contained herein or in any other subsequently filed document which also is or

is deemed to be incorporated by reference herein modifies or supersedes such statement. Any such statement so modified or superseded shall not be deemed, except as so modified or superseded, to constitute a part of this registration statement.
